If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

Do not get on skin or on clothing. Causes eye irritation. Do not get in eyes. Harmful if swallowed. Avoid breathing vapour or mist. Avoid using product in a manner as to directly, or through drift, expose workers or other persons. Always follow the precautionary statements on the label of the pesticide(s) that are to be used with SPRINTA. Applicators and other handlers must wear goggles or a facial splash shield; chemical resistant gloves, such as rubber nitrile > 14 mils or neoprene rubber > 14 mils; overalls or long sleeved shirt and long pants; shoes plus socks and mists filtering respirator. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use wash goggles or face shield, gloves and any contaminated clothing.

Mixing

Mix pesticide product with water when tank is about 30% full. Then when tank is nearly full add SPRINTA. Complete filling tank.

Soil Wetting	Apply 1400 mL/ha in at least 500 L/ha of water	SPRINTA can control dew formation when applied to turf such as athletic fields, tees and greens. Apply as injection through irrigation or by boomspray preferably just prior to irrigation. For hydrophobic areas apply up to 100 mL/100m ² and water in. Re-apply every 14 days or as required.
